

ORDINANCE NO. 2020-09-14-01

AN ORDINANCE AMENDING THE VILLAGE OF SHEFFIELD MUNICIPAL CODE TO PROVIDE AMENDMENTS RELATING TO HEALTH & SANITATION

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF SHEFFIELD:**

SECTION 1: Section **9-3-1** of the Village Code of Sheffield is hereby amended to change the minimum fine from Fifty Dollars (\$50.00) to Two Hundred Dollars (\$200.00) and the maximum fine from Five Hundred Dollars (\$500.00) to Seven Hundred Fifty Dollars (\$750.00).

SECTION 2: The Village Code of the Village of Sheffield is hereby amended by replacing Section **9-3-3** in its entirety with the following:

Burning of Leaves and Landscape Waste

It shall be unlawful for any person to burn leaves or landscape waste, such as domicile waste, garbage, rubbish, construction materials, agriculture waste, trash and trade waste within the Incorporated Limits of the Village of Sheffield. However, the burning of paper, cardboard and small sticks shall be permitted in a burn barrel only. The burn barrel is to be place in the backyard in a cleared area. Burning in said burn barrels is prohibited on Sunday and Monday. The hours for burning in a burn barrel shall be from 8:00 am to 7:00 pm. Tuesday – Saturday. All fires shall be extinguished by 7:00 pm.

SECTION 3: The Village Code of the Village of Sheffield is hereby amended by added Section **9-3-5** as follows:

Loss of Privileges

Any person or property with two (2) burn violations in Chapter 9, Division 3 within a 12 month period will result in NO burning being allowed for that person and/or property for a period of one (1) year.

SECTION 4: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 5 This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 6: The Village Code of the Village of Sheffield, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to the Village Code shall remain in force and effect except as modified by this Ordinance.
